INCLEMENT WEATHER

If weather conditions prevent Counsel in the Hannibal area from traveling to the Hannibal Courthouse, or Court personnel are unable to travel to the St. Louis Courthouse, hearings will be continued to the next regularly scheduled Hannibal docket, unless all parties agree to an earlier setting, and verify the setting with the Court.
