For cause shown, the court may extend the time of any installment, provided the last installment is paid not later than 180 days after filing the petition (Federal Rules of Bankruptcy Procedure 1006 (b)(2))

I understand that if I fail to pay any installment when due my bankruptcy case may be dismissed without further notice or hearing, and I may not receive a discharge of my debts.
