**NEW 341 MEETING SITE  
WENTZVILLE, MISSOURI**

**341 Meetings for Chapter 7 cases filed for residents of St. Charles, Warren and Lincoln Counties in the Eastern Division of the Eastern District of Missouri will be held in the Municipal Courtroom, first floor of the Criminal Justice Center of Wentzville, 1019 Schroeder Creek Blvd., Wentzville, Missouri 63385 beginning in the month of July, 2003.**

**Trustees Robert J. Blackwell and Charles W. Riske will be the two Chapter 7 Panel Trustees appointed to Chapter 7 cases for debtors residing in St. Charles, Warren and Lincoln Counties. Each Trustee will hold one 341 meeting each month, with Mr. Riske's monthly meeting scheduled for the second Friday of each month and Mr. Blackwell's meeting scheduled for the fourth Friday. Mr. Riske's first docket will be Friday, July 11<sup>th</sup> and Mr. Blackwell's first docket will be Friday, July 25<sup>th</sup>. Please note that both of these Trustees will be appointed additionally to Chapter 7 cases for individuals who do not reside in St. Charles, Warren, or Lincoln Counties and who will have**

their 341 meetings in the Eagleton Federal Courthouse. Therefore, it is important for the practitioner to review the Commencement of Case notice and ensure the client follows the notice's instructions as to the 341 meeting site.

**The Criminal Justice Center of Wentzville can be reached from either highway 70 or highway 40/64.**

**Highway 70: Traveling west on 70, two miles west of the highway 70/40 interchange, you will leave 70 at exit 280 and make a right onto the Wentzville Parkway heading north. At 1.4 miles from the exit, you will be coming over a hill and see a single house on your right. Make a right turn onto Schroeder Creek Blvd and you will see the Wentzville Criminal Center on the right side of Schroeder Creek Blvd. You have gone too far if you see on your right the Missouri Cancer Care building.**

**Highway 40/64: Traveling west/north on 40/64, you will see and take the Wentzville Parkway exit (no exit number) and make a left onto the Parkway. Travel 1.2 miles and turn left onto Schroeder Creek Blvd having just passed on your left the Missouri Cancer Care Building. Note that this intersection does not have stop signs nor traffic lights.**

**Continued and rescheduled 341 meetings will be set for a future date and time as agreed to by the assigned Trustee at the Wentzville Criminal Center.**

**Docket Hours will be 9:00 am, 10:30 am and 1:30 pm. Business cases will not be set on a particular docket hour.**

**All Chapter 12 and 13 Debtor Cases with venue in the Eastern Division, Eastern District of Missouri, including debtors resident in St. Charles, Warren, or Lincoln County, will continue to have their 341 meetings heard at the Eagleton Federal Courthouse in downtown St. Louis.**

**Conversion from Chapter 7 of a case filed by a resident of St. Charles, Warren, or Lincoln County to another bankruptcy chapter will require the resignation of either Trustee Backwell or Trustee Riske followed by the appointment of a new Trustee who will hear the 341 meeting in the Eagleton**

**Federal Courthouse in downtown St. Louis.**

**Conversion to Chapter 7 of a case from another chapter filed by a resident of St. Charles, Warren, or Lincoln County will result in the appointment of a Trustee for a 341 meeting to be held in the Eagleton Federal Courthouse in downtown St. Louis.**

**Telephones: Individuals will not be able to call into the 341 meeting room at the Wentzville Criminal Center. A public pay telephone will be installed near the meeting room.**

**Copying Documents: There are no facilities for persons attending 341 meetings at the Wentzville Criminal Center to make copies of documents. Therefore, it is incumbent on all attendees to bring sufficient copies of pertinent documents in order to fully participate in the meeting and to provide the Trustee with required information.**
