

## United States Bankruptcy Court - Eastern District of Missouri

### CM/ECF Release 3.3.2 Implementation

On Sunday, September 13, 2009, CM/ECF will be down from 9:00 a.m. to 5:00 p.m. to add CM/ECF Release 3.3.2 to the live database. The new CM/ECF product will be ready for use on Monday, September 14, 2009. Addressed below are some changes in CM/ECF Release 3.3.2 designed to encourage the appropriate redaction of documents filed through CM/ECF.

1) CM/ECF Filer or PACER Login Screen - A checkbox has been added to the notice of redaction responsibility to affirm that the notice has been read and understood. It is required to check the box to log into CM/ECF. The rule title Fed. R. Bankr. P. 9037 is now a hyperlink to the text of the rule.

**Instructions for filing:**  
Enter your CM/ECF filer login and password if you are electronically filing something with the court.

2) Redaction Message when Docketing - When making either a docket entry or claim entry, a message appears stating “Have you redacted?” to remind filers to eliminate personal identifiers before filing the document in CM/ECF. Listed below is how this appears in docket entry and claim entry.

a. Docket Entry - The redaction message appears on the final docket text screen.
