



January, 2010 Case Processing Statistics


New Cases by Chapter

During the month of January, there were 989 cases filed with the Court. Of those cases, 679 cases were filed under Chapter 7, 1 case was filed under Chapter 11, and 309 cases were filed under Chapter 13. There were no cases filed under any other Chapter. 
New Cases by Division

The chart below depicts the number of new cases filed per division in January.




New Adversaries by Division
