



February, 2010 Case Processing Statistics


New Cases by Chapter

During the month of February, there were 1,228 cases filed with the Court. Of those cases, 892 cases were filed under Chapter 7, 2 case was filed under Chapter 11, and 334 cases were filed under Chapter 13. There were no cases filed under any other Chapter. 
New Cases by Division

The chart below depicts the number of new cases filed per division in February.




New Adversaries by Division
