



March, 2010 Case Processing Statistics


New Cases by Chapter

During the month of March, there were 1,849 cases filed with the Court. Of those cases, 1,427 cases were filed under Chapter 7, 2 case was filed under Chapter 11, 1 case was filed under Chapter 12, and 419 cases were filed under Chapter 13. 
New Cases by Division

The chart below depicts the number of new cases filed per division in March.




New Adversaries by Division
