




New Cases by Chapter

During the month of June, 2012, there were 1,142 cases filed with the Court. Of those cases 832 cases were filed under Chapter 7, 1 case was filed under Chapter 11 and 309 cases were filed under Chapter 13. There were no cases filed under any other Chapter. 
New Cases by Division

The chart below depicts the number of new cases filed per division in June, 2012.




New Adversaries by Division
