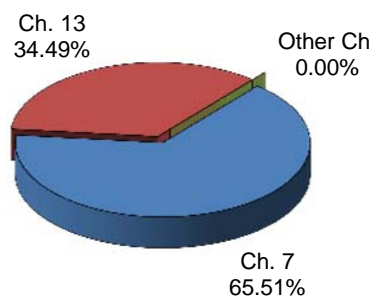

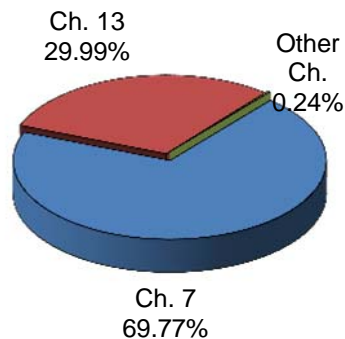

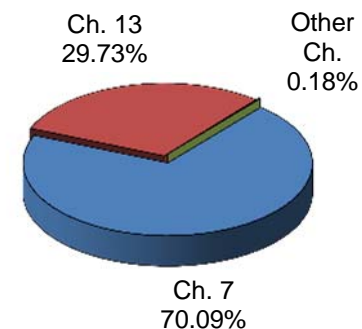
**2014 Current Month Comparison**
