




New Cases by Chapter

During the month of December, 2014, there were 822 cases filed with the Court. Of those cases 546 cases were filed under Chapter 7, 1 case under Chapter 11 and 275 cases were filed under Chapter 13. 
New Cases by Division

The chart below depicts the number of new cases filed per division in December, 2014.




New Adversaries by Division
