

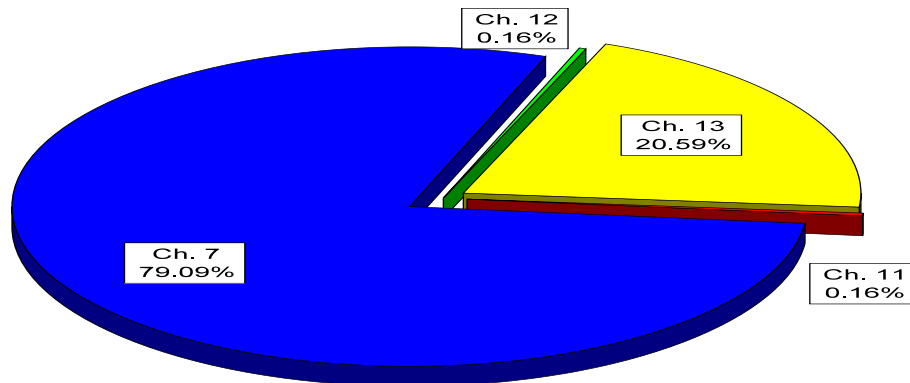

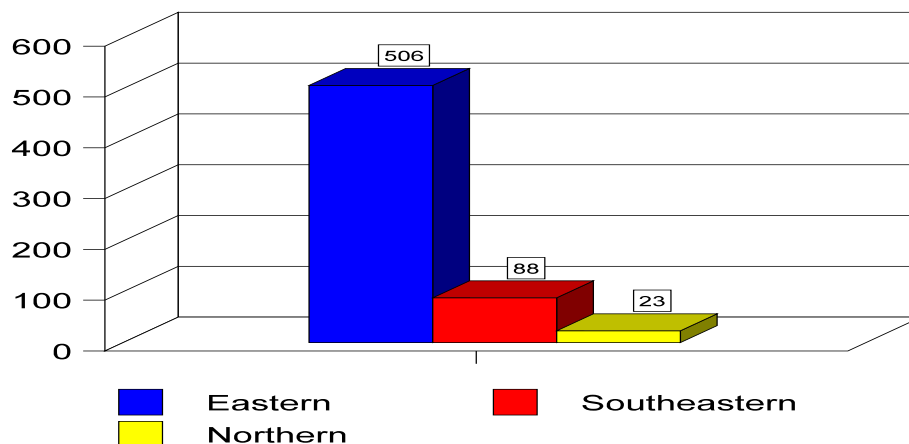
New Cases by Chapter

During the month of June, 2020, there were 617 cases filed with the Court. Of those cases 488 cases were filed under Chapter 7, 1 case was filed under Chapter 11, 1 case was filed under Chapter 12 and 127 cases were filed under Chapter 13. 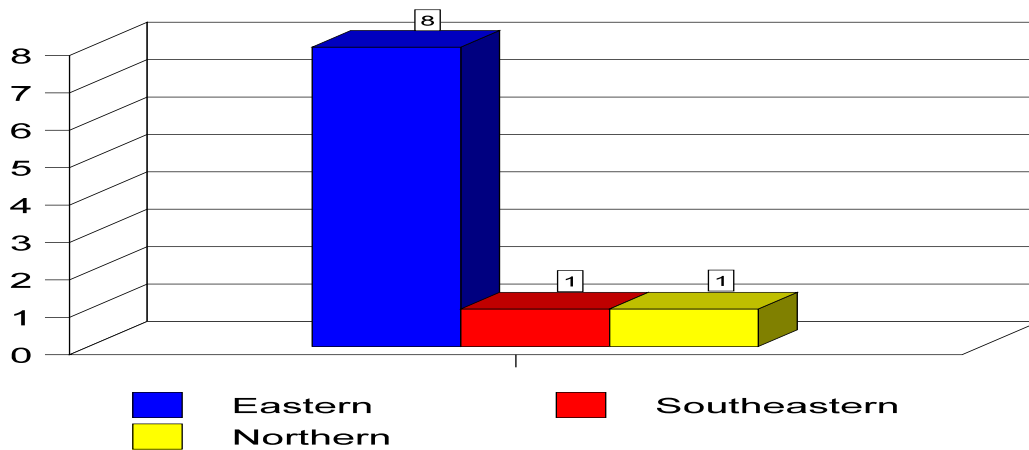
New Cases by Division

The chart below depicts the number of new cases filed per division in June, 2020.



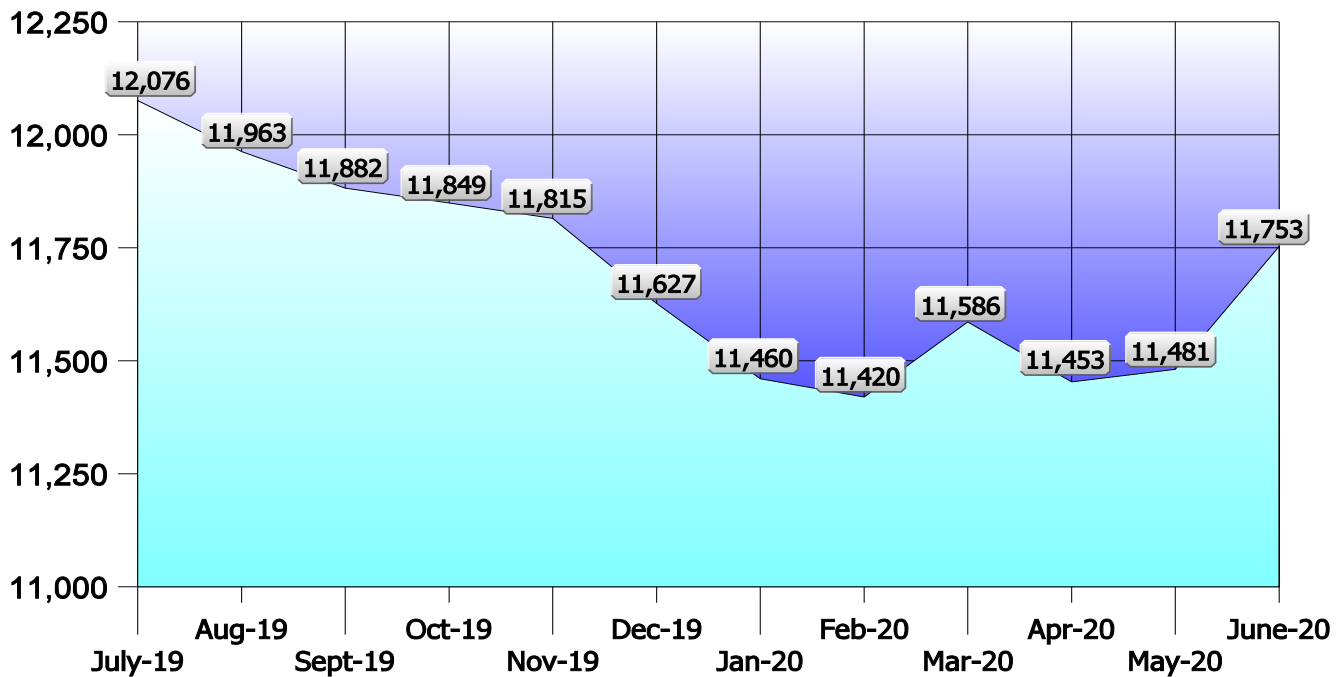
New Adversaries by Division
