

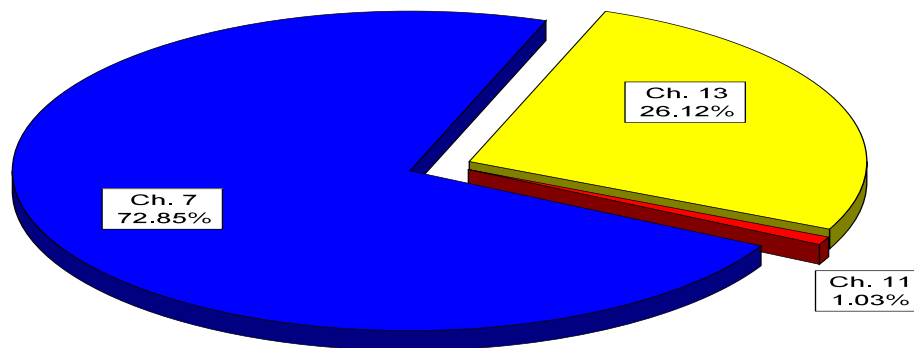

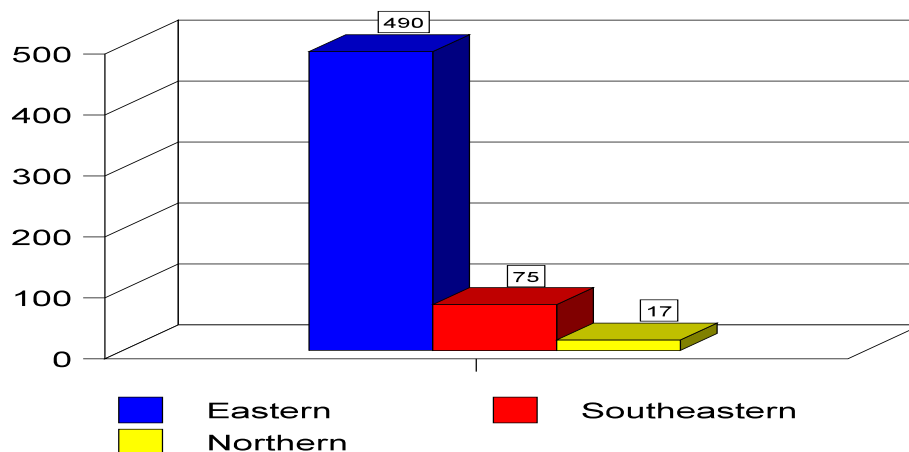
New Cases by Chapter

During the month of July, 2020, there were 582 cases filed with the Court. Of those cases 424 cases were filed under Chapter 7, 6 cases were filed under Chapter 11 and 152 cases were filed under Chapter 13. There were no cases filed under any other Chapter. 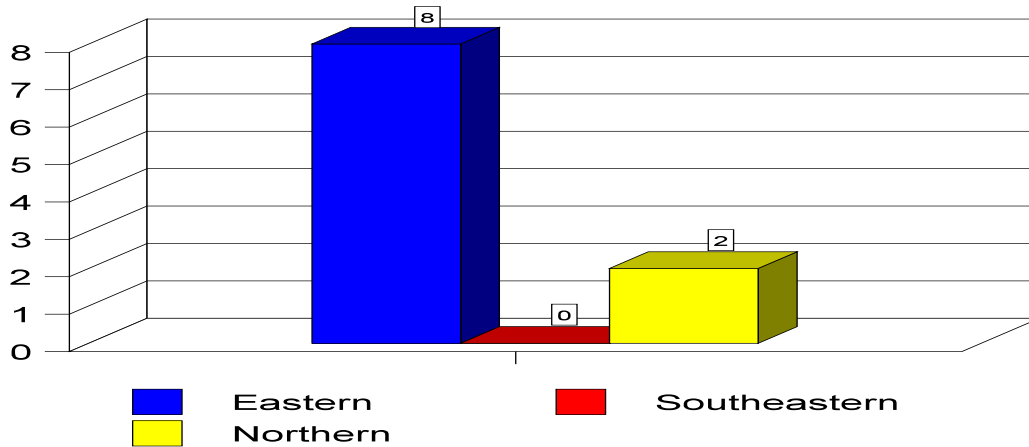
New Cases by Division

The chart below depicts the number of new cases filed per division in July, 2020.



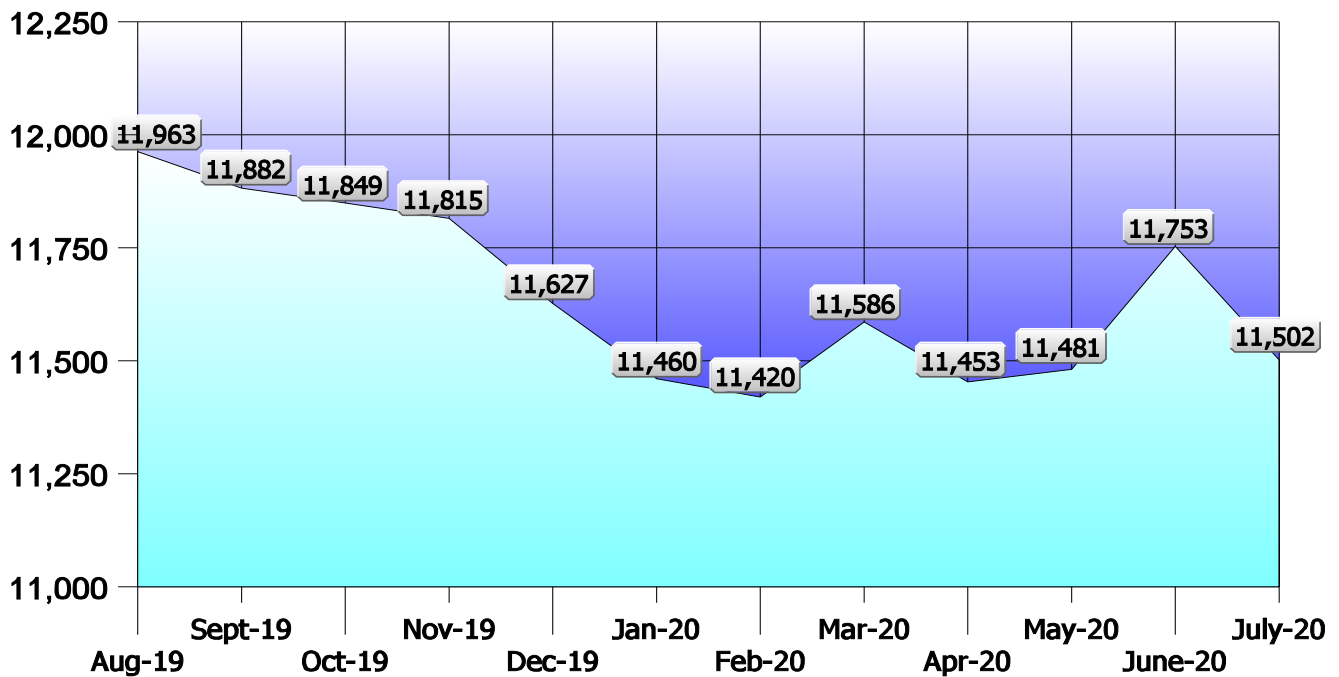
New Adversaries by Division
