

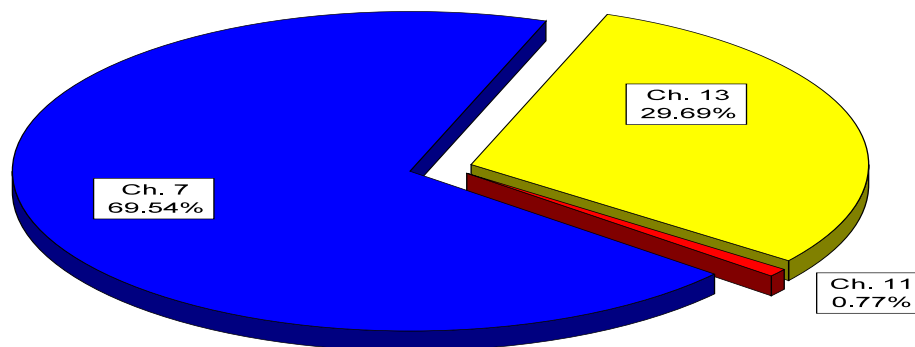

August 2020, Case Processing Statistics

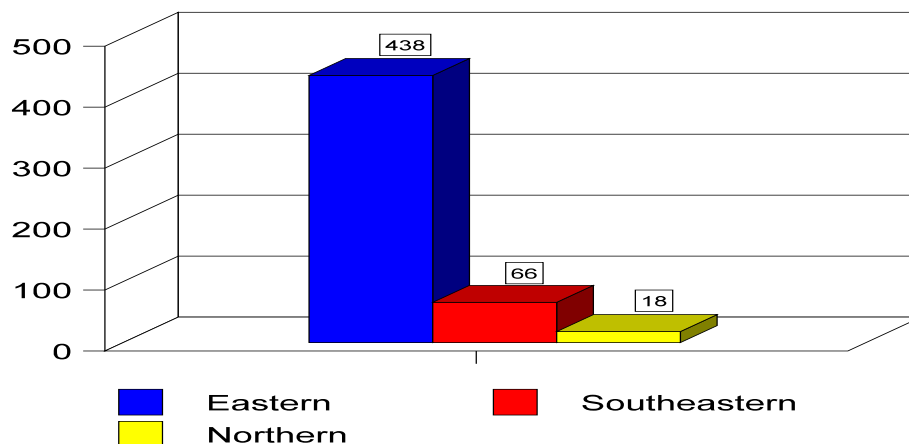
New Cases by Chapter

During the month of August, 2020, there were 522 cases filed with the Court. Of those cases 363 cases were filed under Chapter 7, 4 cases were filed under Chapter 11 and 155 cases were filed under Chapter 13. There were no cases filed under any other Chapter. 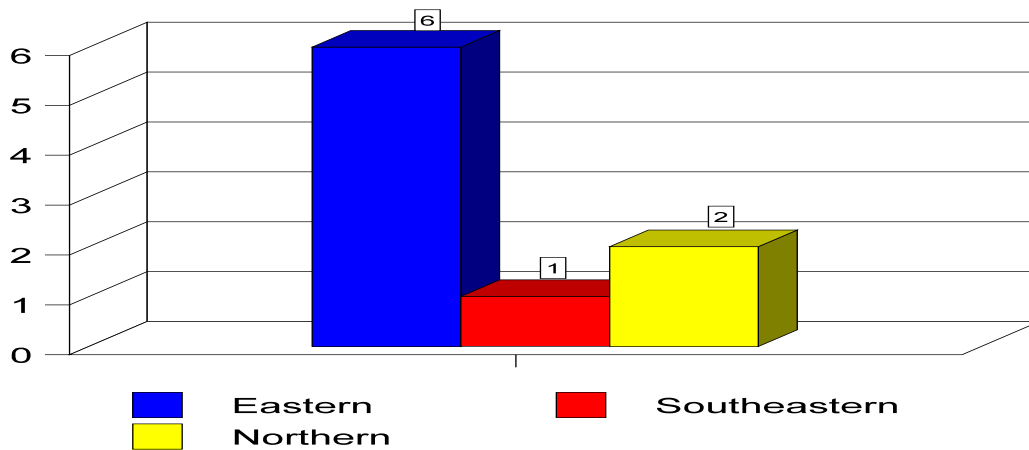
New Cases by Division

The chart below depicts the number of new cases filed per division in August, 2020.



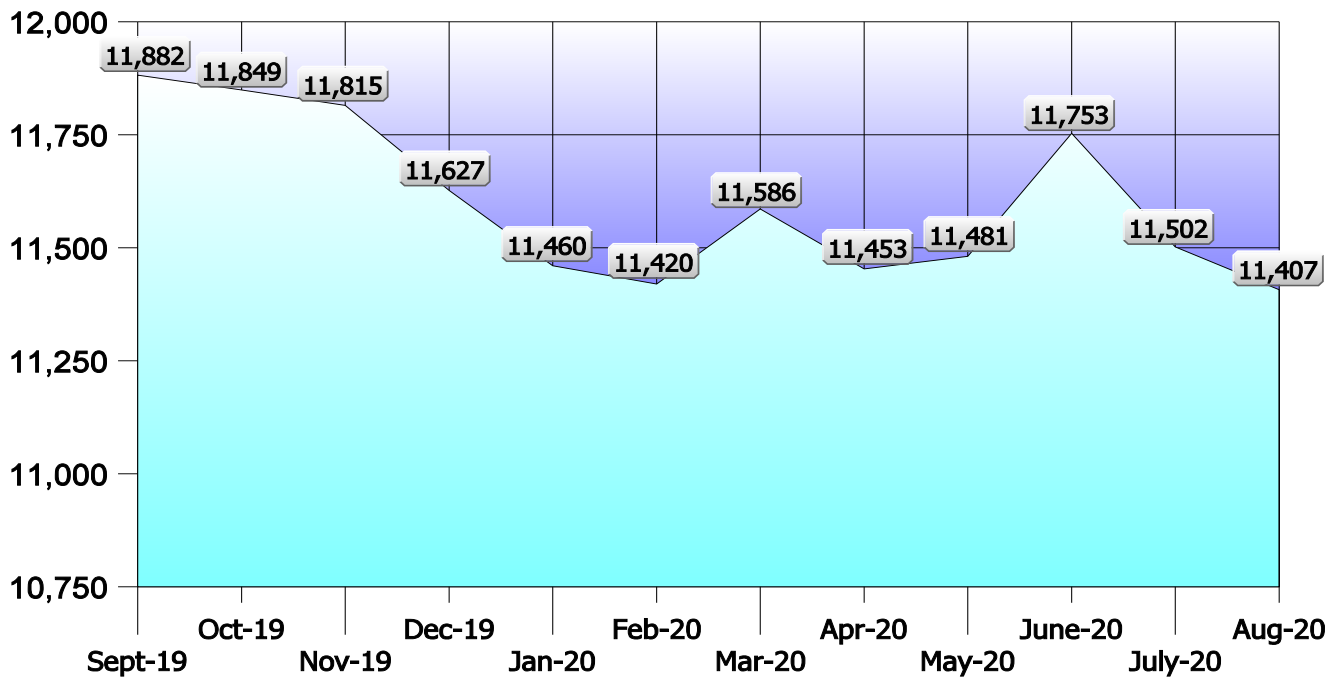
New Adversaries by Division
