

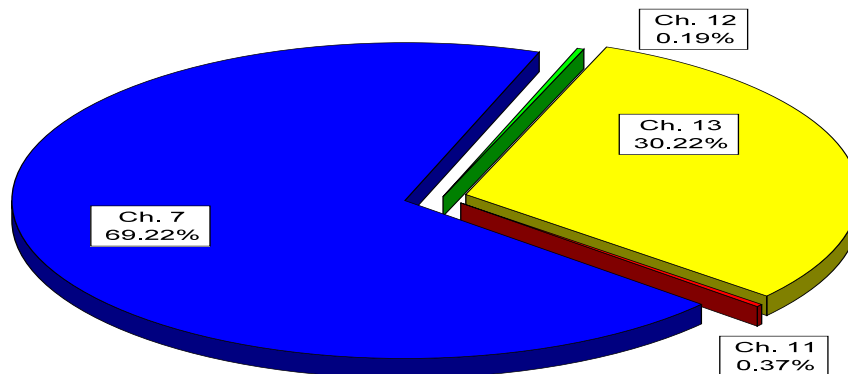

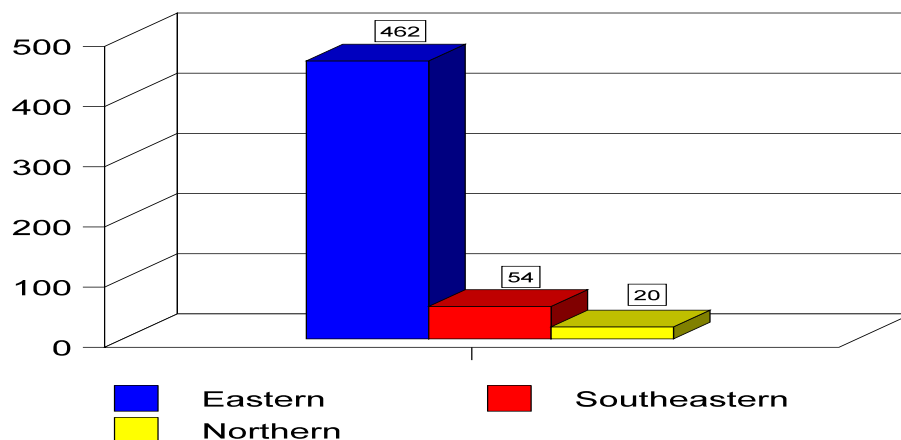
New Cases by Chapter

During the month of October, 2020, there were 536 cases filed with the Court. Of those cases 371 cases were filed under Chapter 7, 2 cases were filed under Chapter 11, 1 case was filed under Chapter 12 and 162 cases were filed under Chapter 13. 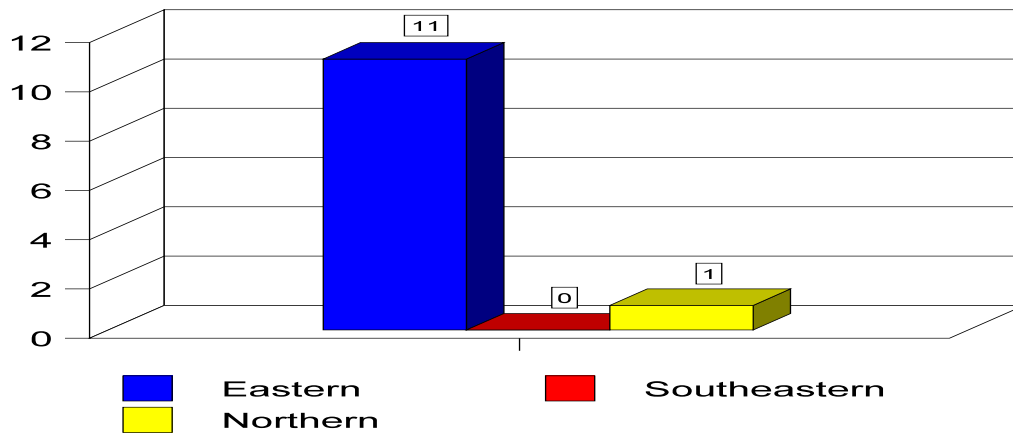
New Cases by Division

The chart below depicts the number of new cases filed per division in October, 2020.



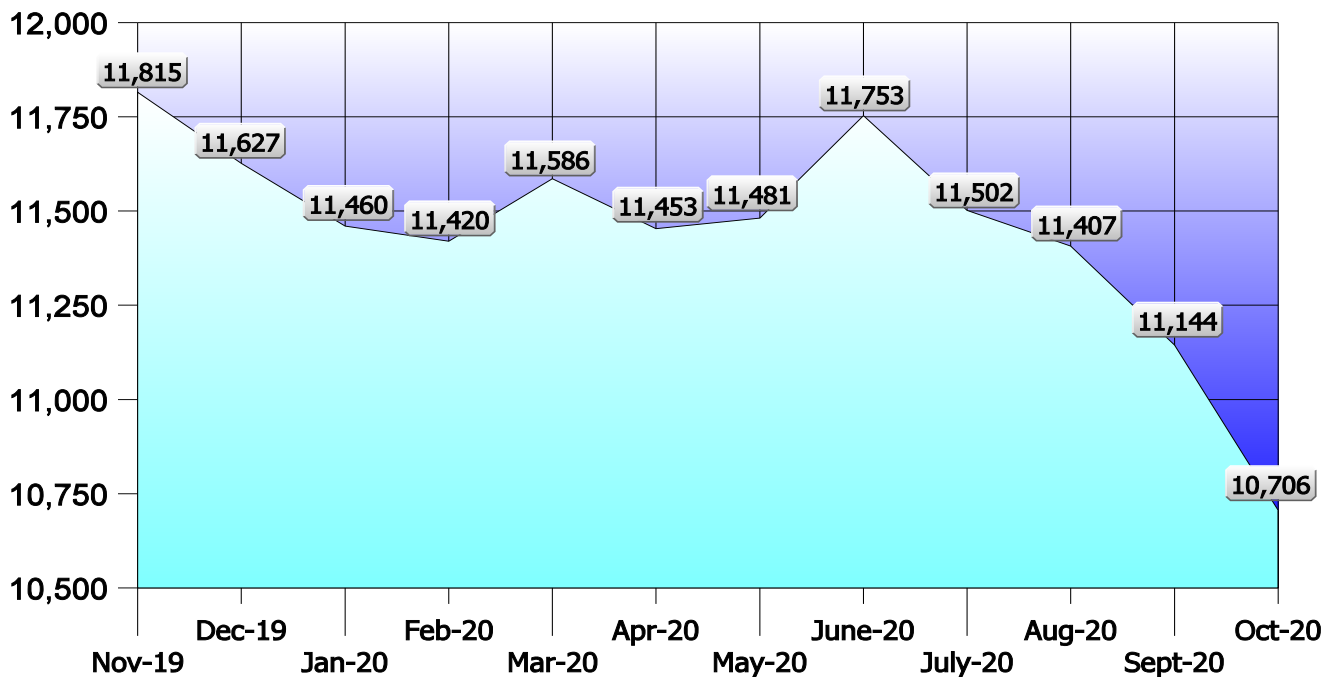
New Adversaries by Division
