

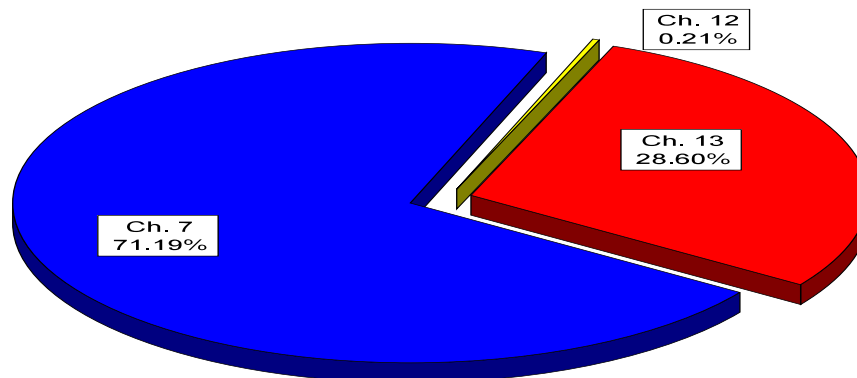

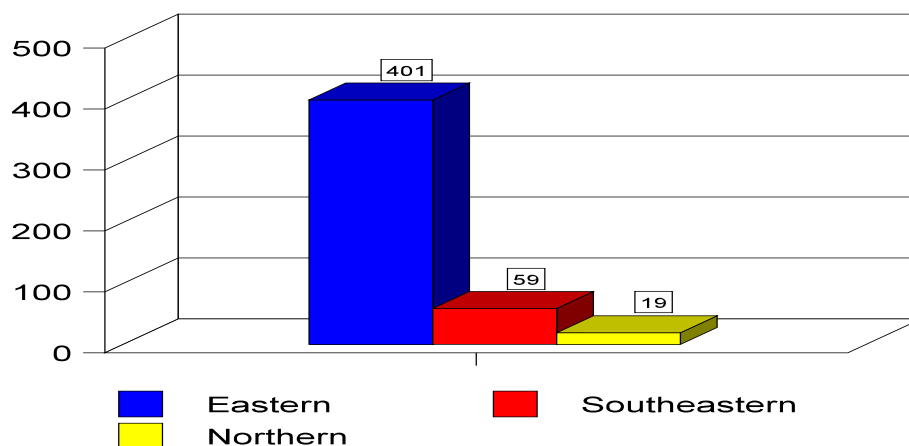
New Cases by Chapter

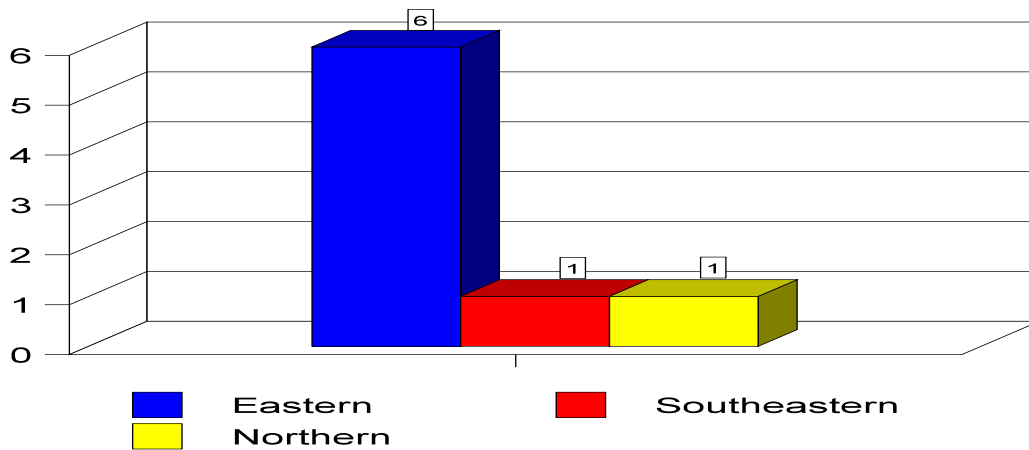
New Cases by Division

The chart below depicts the number of new cases filed per division in November, 2020.



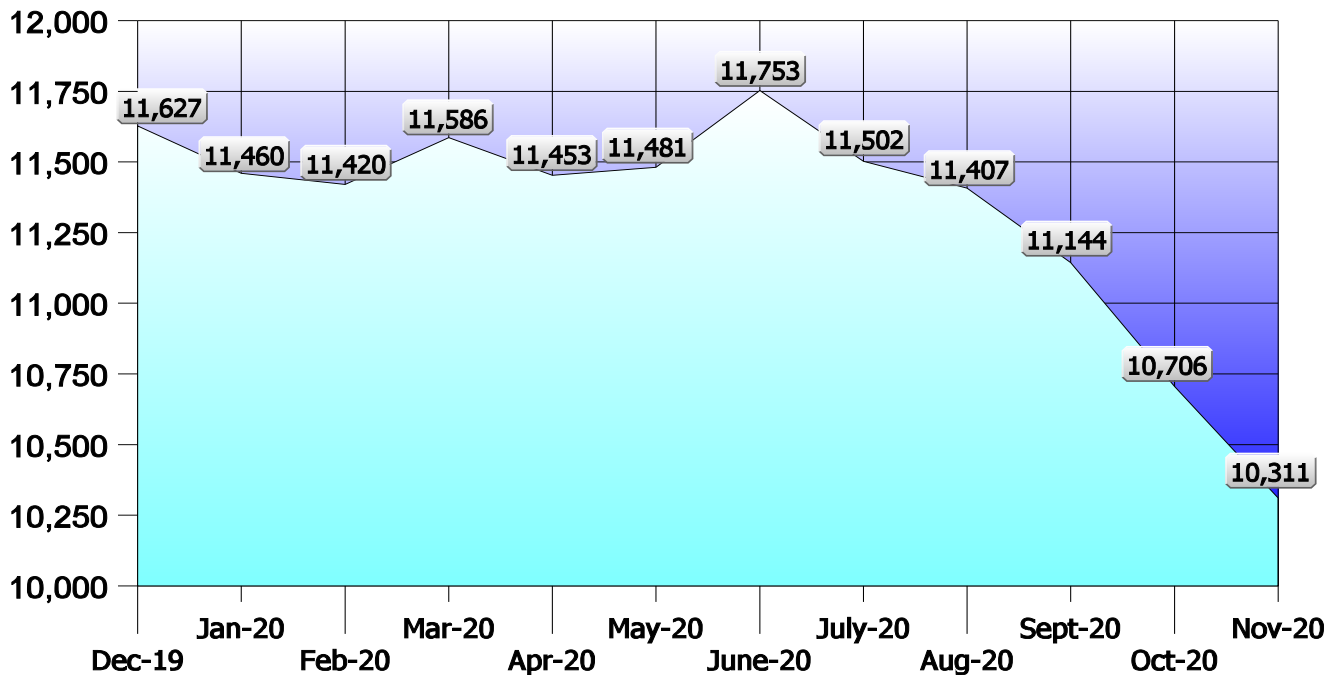
New Adversaries by Division
