## REVISED LOCAL RULES AND PROCEDURES MANUAL

Effective June 5, 2008

The United States District Court for the Eastern District of Missouri and the Eighth Circuit Court of Appeals have approved the revised Local Rules presented by the United States Bankruptcy Court for the Eastern District of Missouri. The revised Local Rules are effective <u>June 5, 2008</u>. These revised Local Rules replace the current Local Rules and the interim procedures set forth in the Court's Implementation Order for all cases filed on or after June 5, 2008. Revisions have also been made to the Procedures Manual. These will also take effect on <u>June 5</u>, <u>2008</u>. This revised Procedures Manual will replace the current Procedures Manual and the CM/ECF Administrative Procedures Manual for all cases filed on or after June 5, 2008. Essentially, instead of having a Procedures Manual, a CM/ECF Administrative Procedures Manual, an Implementation Order, and the Local Rules governing cases filed on or after June 5, 2008, the Court will now only have the revised Procedures Manual and the revised Local Rules.
