

**NOTICE REGARDING MEDICAL RECORDS FROM
SAINT LOUIS CONNECTCARE, Chapter 7 bankruptcy number 13-51143-705**

FORMER PATIENTS OF ST. LUKE’S HOSPITAL, ST. LOUIS REGIONAL MEDICAL CENTER/HOSPITAL, SAINT LOUIS CONNECTCARE HOSPITAL AND SAINT LOUIS CONNECTCARE (SPECIALTY, URGENT CARE, AMBULATORY SURGERY (ENDOSCOPY) AND/OR PHARMACY):

Saint Louis ConnectCare (“SLCC”) ceased operations on November 15, 2013 and filed bankruptcy on December 16, 2013. At that time, SLCC possessed or controlled medical, patient and pharmaceutical records related to its operations and the operations of the hospitals and medical centers named above. By Order dated April 14, 2014, the United States Bankruptcy Court for the Eastern District of Missouri (the “Bankruptcy Court”) authorized procedures for the destruction and retention of patient and other medical records in the possession or control of the bankruptcy estate. Under the Bankruptcy Court’s April 14, 2014 Order, all medical, patient, pharmaceutical and other records for St. Luke’s Hospital, St. Louis Regional Medical Center/Hospital, Saint Louis ConnectCare Hospital, and Saint Louis ConnectCare (Specialty, Urgent Care, Ambulatory Surgery (Endoscopy) and/or Pharmacy) dated on or before December 31, 2005 have been destroyed.

Pursuant to the Bankruptcy Court’s April 14, 2014 Order, medical, patient, pharmaceutical and other records for Saint Louis ConnectCare (Specialty, Urgent Care, Ambulatory Surgery (Endoscopy) and/or Pharmacy) dated on or after January 1, 2006 may be obtained by contacting:

The costs to obtain medical records are as follows:

Copy to another physician or health provider = No charge, other than postage.
Patient request = \$.54 per page, plus postage.
Legal request = \$.54 per page plus \$22.80 administrative fee and postage.
